EL SALVADOR

CASA 03/82 15 recent arrests

The following persons were detained between 9 - 27 January 1982 by members of the Salvadorian security forces. The detention of the people named below has not been acknowledged by the Salvadorian authorities. There are grave fears that they might "disappear" if not acknowledged to be in detention.

- 1. Luis Ernesto GONZALEZ ALVARADO Student, aged 16, arrested at 3 pm on 27 January 1982 at his home in colonia San Bartolo, San Salvador by members of the security forces. His abductors tied his thumbs together and took him away in a red truck.
- 2. Francisco Antonio FERRER SANCHEZ Worker, aged 22, arrested at his home in colonia Dolores, San Salvador at 10.30 pm on 26 January 1982 by uniformed members of the army.
- 3. Pablo PEREZ SALAZAR Tailor, aged 38, arrested at his home in San Salvador on 24 January 1982 by uniformed members of the army and other security forces.
- 4. Emigdio SALGADO FLAMENCO Employee of IRA (Instituto Regulador de Abastecimientos, Institute for Regulating Supplies) arrested on 24 January 1982 at his home in Soyapango by men in plainclothes who identified themselves as members of the National Police.
 - 5. Jorge Alberto PEREZ Employee, aged 23, married, arrested at 11 am on 23 January 1982 at his place of work Casa Melendez in San Salvador by members of the security forces.
 - 6. Salvador Alberto PALACIOS Primary school teacher, aged 45, arrested in late January 1982 at his school in Quezaltepeque. .
 - 7. Juan Antonio DURAN VALLADARES Worker, aged 22, arrested by army patrol near the Modelo cinema, San Salvador on 21 January 1982.

- 8. Luis Alonso LOPEZ GALAN
 Carpenter, aged 38, arrested at 1 am on 21 January 1982 at his home in
 Ciudad Delgado by members of the army.
- 9. Gonzalo David ALFARO GARCIA
 Tailor, aged 25, arrested on 19 January 1982 in colonia Cucumacayan by
 members of the army who forced him into a vehicle with no numberplates.
 During the arrest, he was shot in the legs. Three army tanks later arrived
 at his home and members of the army raided his home.
- 10. Efrain SUAREZ MENJIVAR
 Student, aged 21, arrested at 12.20 pm on 16 January 1982 at his home in
 San Salvador by Hacienda police, and taken away in an army jeep.
- 11. Jorge Alberto GARCIA Arrested on 16 January 1982 in the centre of San Salvador by members of the security forces.
- 12. Marcelino MARTINEZ
 Carpenter, aged 27, married, arrested at 8 am on 16 January 1982 as he was leaving his home in Apopa by members of the security forces.
- 13. Juan Antonio MEJIA ACOSTA Construction worker, aged 24, arrested at 9 am on 14 January 1982 in San Salvador by members of the army.
- 14. Nelson Ernesto AYALA Student, aged 17, arrested by soldiers of the airforce at 9 am on 9 January 1982 near the airforce base by Ilopango airport.
- 15. Julio Miguel MARTINEZ MARTINEZ Employee, aged 21, arrested on 9 January 1982 in San Salvador.

Background information

Human rights violations on a massive scale in El Salvador continue to be brought to the attention of Amnesty International. Amnesty International is aware that these violations of human rights have occurred at a time of civil conflict between guerrilla groups and the Salvadorian authorities. However, there is a systematic pattern of human rights violations, including torture, "disappearance" and cold-blooded murder being carried out by the Salvadorian security forces, and directed against people not involved in guerrilla activities. Testimonies received by Amnesty International implicate all branches of the Salvadorian security forces in gross abuses of human rights.

Recommended Action

Telegrams/express letters/letters expressing concern about the arrest of these 15 people and urging that their phsycial safety be guaranteed. Please also request details of their place of detention and their legal situation.
