EL SALVADOR: Recent arrests and abductions

## 1. People detained by the National Police:

- Luz America VAQUERANO, medical student, detained on 19 February 1981 by members of the National Police in plain clothes in San Salvador; her present whereabouts are unknown;
- Maximiliano MONTOYA PINEDA, aged 27, worker at Lido S.A. company, was detained on 18 February 1981 by members of the National Police in plain clothes in San Salvador; his present whereabouts are unknown;
- Joaquín CACERES AREVALO, aged 40, a guard at the Instituto Salvadoreño de Seguro Social (ISSS), detained on 31 January 1981 and reportedly being held by the National Police;
- Juan José CACERES HERNANDEZ, aged 14, son of Joaquin Caceres Arevalo, detained on 19 December 1980 and reportedly being held by the National Police;
- Marta ALAS, aged 20, detained at 6.30 am on 17 January 1981 in Montecarmelo by members of the National Police and reportedly being held by the National Police;
- Alejandro MOLINA LARA, aged 36, detained at 7.00 am on 15 January 1981 in San Salvador by members of the army and reportedly being held by the National Police:
- Alberto QUEZADA, aged 30, medical doctor, detained in January 1981 by members of the armed forces in eastern El Salvador and reportedly being held by the National Police;
- Seiso CASTRO, aged 38, surgeon, detained by rembers of the army in January 1981 in San Miguel and reportedly being held by the National Police.

Joaquin Caceres Arevalo and Juan José Caceres Hernandez are father and brother respectively of a member of the El Salvadorian Human Rights Commission (Comision de Derechos Humanos de El Salvador) which has been frequently harassed by the security forces during recent months. The information and administrative secretary of the Commission was abducted from his home in San Salvador on 25 January; he was detained by the National Police until 11 February. Other relatives of people connected with the Commission have also been victims of abduction; on 3 February 1981 Ramon Turcios Paniagua, aged 47, the father of the person in charge of the photographic laboratory of the Commission was seized from his home by members of the air force — he was subsequently found dead five blocks from his home.

## 2. People seized by the National Guard from Santa Tecla prison:

Mauricio SARAVIA and Ing. Guillermo Antonio OLIVA MONTOYA were seized from the prison of Santa Tecla on 18 February 1981 by members of the National Guard; their present whereabouts are unknown.

AI has received information from relatives of prisoners detained in the prison of Santa Tecla that prisoners are being harassed by security guards and have had tear gas bombs thrown into their cells.

## 3. Person arrested by members of the Air Force:

Carlos Alberto VASQUEZ SANCHEZ, aged 26, a medical student and teacher at the El Milagro Academy in Soyapango, was arrested by members of the Air Force in Soyapango on 19 February 1981 at his home; his present whereabouts are unknown.

AI is gravely concerned about the safety of all these people.

Telegrams/express letters expressing concern at the arrest of these people and requesting the authorities to ensure that their physical safety is guaranteed.
