Amnesty International has received reports that Arely de Renderos Siliezar and Sonia del Carmen Aguiñada are both being held in acknowledged detention in the main women's prison at Ilopango. No further news has been received of Adelina Chicas and her daughter Elizabeth.

Amnesty International has received no further news of Alfredo Acosta Díaz or the other people arrested with him.

### Dr. José Vicente AREVALO

Amnesty International has learned that Dr. Arévalo was recently released. No further details are as yet available.

# CASE 1

## Re: Isaac Nelson Renderos Siliezar

Please continue to follow the instructions given in CASA 16/83 (AMR 29/24/83) of 15 July 1983.

## Re: Adelina Chicas and her daughter Elizabeth

Please continue to ask for clarification of the whereabouts of these two people, for assurances that their physical integrity be guaranteed while in detention and that they be released unless formally charged and brought before a court of law.

# Re: Arely de Renderos Siliezar and Sonia del Carmen Aguiñada

Enquire about the exact details of the charges brought against the two women

and when their trial is to take place. Ask for assurances that internationally accepted standards for a fair trial be adhered to in any eventual proceedings against them.
