EL SALVADOR: Pedro FLORES PEÑA

Hugo Francisco CARRILLO CABRERA

Amnesty International has received reports that Pedro Flores Peña was found dead on 24 September 1983. His wife is reported to have found his severely tortured and decapitated body near the University of El Salvador. Pedro Flores Peña was a law student at the university. He was abducted in San Salvador on 13 September 1983.

According to one report, four days after the body was found the *Ejército* Secreto Anticommunista (Secret Anti-Communist Army), a paramilitary group, admitted that they had kidnapped Pedro Flores Peña but claimed that he was still alive and that his wife had mistakenly identified her husband.

Amnesty International is concerned about reports that several other students and teachers at the University of El Salvador have been abducted during the past few weeks. Amilcar MARTINEZ ARGUERA, a professor at the International Relations Department at the university, is reported to have been taken from his home in San Salvador on or around 20 September 1983. Amilcar Martínez Arguera is also the director of social and economic affairs at the Foreign Ministry. A right-wing "death squad", the Brigada Maximiliano Hermández Martínez, is reported to have claimed responsibility for his abduction.

On 24 September 1983 two students at the university, Jaime ENRIQUEZ BAUTISTA and Carlos Adilio DIAZ, were reported to have been abducted by men in civilian clothes as they were leaving an office at the university.

The present whereabouts of these three men are unknown and Amnesty International is seriously concerned about their safety.

Amnesty International has received no further news about Hugo Francisco Carrillo Cabrera, head of the International Relations Department at the University of El Salvador, who was abducted on 14 September 1983 by armed men believed to be members of the security forces. Fears for his safety continue.

Further recommended action:

Please continue to send appeals:

- expressing concern about the abduction of Hugo Francisco Carrillo Cabrera, Amilcar Martínez Arguera, Jaime Enríquez Bautista and Carlos Adilio Díaz
- urging that their whereabouts be made known and that they be humanely treated while in detention
- requesting that they be immediately released unless charged and brought before a court
- requesting an independent investigation into the reported abduction and death of Pedro Flores Peña and that those responsible be brought to justice

 Telegrams and letters should be brief and courteous. Stress that your concern for human rights is not in any way politically partisan. Refer to relevant provisions in international law, such as the United Nations Universal Declaration of Human Rights:

Article 3 — "Everyone has the right to life, liberty and security of person."

Article 5 — "No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment."

Article 9 - "No one shall be subjected to arbitrary arrest, detention or exile."

and Membership Department of the International Secretariat. If appropriate, thank the official who has replied and ask to be kept informed about the case.
