Six recent arrests

The following six people have been arrested in El Salvador during the past few weeks. In all but one of the cases the authorities have not acknowledged the detentions and in only two cases is there any indication of where they might be being held. They were all detained by armed men, some in military uniform and others in plain clothes. Amnesty International is gravely concerned about the safety of these people.

- 1. Francisco Antonio PENATE MELARA
 Aged 38, married with one child, Director of the Department of Business
 Administration at the University of San Salvador, also runs his own business.
 He was reportedly taken from his personal business office in San Salvador
 at 3.30 p.m. on 30 June by armed men. Unofficial reports indicate that he
 was seen alive in the headquarters of the Guardia Nacional shortly afterwards,
 and that interrogation was to begin on 2 July.
- 2. Pablo Plutarco APARICIO VALENZUELA + one other
 Driver, aged 36, arrested at 12.30 p.m. on 30 May 1982 in his home in Colonia
 San José Las Flores, Apopa, Departamento de San Salvador, by army troops, some
 in uniform and others in plain clothes. He was taken away with another person
 whose name is not known.
- 3. Oscar Armando SALAZAR HERNANDEZ Student, aged 13, living in Santa Ana, Departamento de Santa Ana, arrested at 5.50 p.m. on 24 May 1982 near a cinema in Santa Ana by members of the Policia Nacional.
- 4. Benjamin LOPEZ RAMIREZ
 Worker, aged 35, living in Soyapango, Departamento de San Salvador, arrested at 6 p.m. on 14 May 1982 at a bus stop in San Salvador by members of the security forces.
- 5. Ana Gloria CRUZ CASTILLO
 Student, aged 22, living in Colonia Amatepec, Soyapango, Departamento de San
 Salvador, arrested at home at 10.30 p.m. on 27 April 1982 by armed men in
 plain clothes believed to be from the Policia Nacional, who were travelling
 in a vehicle with a rotating red light on top. It is reported that the
 Policia Nacional confirm they are holding her for investigation.

RECOMMENDED ACTION

Telegrams/express letters/ letters to the Salvadorian authorities expressing concern at the arrest of the above six people, requesting clarification of their whereabouts and legal situation, and urging that their physical safety be guaranteed.

Each group should send appeals to one or two government ministers and/or heads of the security forces or armed forces, selecting the most appropriate ones according to the information available, e.g. in the case of No. 1, appeals should be directed to the Minister of Education and the head of the Guardia Nacional. Most addresses can be found in AMR 29/39/82 of 21 May 1982. Others are given below.
