The detention of the following persons has not been acknowledged by the Salvadorian authorities and there are grave fears for their safety while they are held in incommunicado detention.

Fedor Stanley MENJIVAR Ana Isabel MORAN POSADA DE MENJÍVAR Marta REYES

Fedor Stanley MENJÍVAR surgeon (34), his wife Ana Isabel MORÁN POSADA DE MENJÍVAR (35), surgeon, and Marta REYES, maid, were arrested by uniformed National Police at 2.00 pm on 14 August 1981 at the Menjívar home in Colonia Providencia, San Salvador.

Background information

Human rights violations on a massive scale in El Salvador continue to be brought to the attention of Amnesty International. Amnesty International is aware that these violations have occurred at a time of escalating civil conflict between guerrilla groups and the Salvadorian authorities and is aware of reports of human rights violations having been committed by non-governmental forces. However there is a systematic pattern of human rights violations, including torture, "disappearances" and cold-blooded murder being carried out by the Salvadorian security forces, and directed against people not involved in querrilla activities. Testimonies received by Amnesty International implicate all branches of the Salvadorian security forces in gross abuses of human rights.

Recommended Action

Please send separate appeals for the two groups.

Telegrams/express letters/letters expressing concern at the arrest of these people and requesting the authorities to ensure that their physical safety is guaranteed. You should also ask for information on their place of detention.
