Recent murders in El Salvador of Christian Democrats

Amnesty International has received reports of the killing of another Christian Democrat mayor in El Salvador. 47-year-old Ramiro PONCE, the mayor of San Lorenzo near San Salvador, was found dead in mid-August. A newspaper report quoted his mother as saying that she found his body shattered by the impact of several volleys of rifle fire at virtual point-blank range. Ponce is the fourteenth Christian Democrat leader to have been killed since the March 1982 elections. Background

As reported in AMR 29/67/82, the Christian Democrats were granted four posts in the current government of El Salvador following the elections for a constituent assembly held in March 1982. According to the Partido Democrata Cristiano (PDC), Christian Democratic Party, the attacks on them are due to a polarization between themselves and the armed forces which occurred at the time of the election and has continued since then. The party claims that, apart from attempts to physically eliminate their parliamentary and municipal representatives, other parties in the government coalition are deliberately seeking the removal of the Christian Democrat ministers. In August, PDC leader and deputy education minister Roberto Serrano is reported to have received anonymous death threats. following the arrest on charges of guerrilla activity of a woman called Ana Lidia Escalante, widely reported to the wife of Serrano. Serrano was eventually forced to resign when a different woman produced a certificate showing she was married to him, thus implying that he was a bigamist. Follow up any actions taken on the basis of CASA 42/82 (AMR 29/67/82) by sending further appeals expressing concern at the killing of Ramiro Ponce and urging that those responsible be brought to justice. As before, groups may like to approach Christian Democrat parties and members of Parliament or members of government in their country, asking them to address appeals to the Salvadorian authorities. If contact was made previously with members of the European Parliament or Latin American Parliament, please inform them of this latest incident and request them to send further appeals.
